## A RESOLUTION TO ADOPT A CHANGE IN WATER/SEWER RATES FOR USERS WITHIN THE VILLAGE OF LYONS

WHEREAS, the Village of Lyons provides water and sewer services to commercial and residential users at rates which cover actual costs to the village, yet assuring high quality service, and

WHEREAS, water and sewer rates have not been formally evaluated since May, 2019 in relation to current and anticipated operating costs, other than a 3% general across the board cost-of-living increase in December, 2020, and

WHEREAS, having had both water and sewer rates considered by the Michigan Rural Water Association regarding current and future operating costs, capital improvements and project needs.

NOW, THEREFORE BE IT RESOLVED that the Lyons Village Council hereby approves that residential and commercial water/sewer rates be changed to reflect the following table:
