Approval of Agenda: A motion was offered by Trustee Darling, seconded by Trustee Russell to approve the agenda, as written. **Motion was carried by voice vote, as written.**

Approval of the Treasurer's Report: Treasurer Gould reported the additional road and bridge funding was received on April 3, 2018 in the amount of \$8444.56, a CDARS that matured 4/5/18 was reinvested for 1 year at 1.88% interest rate and Audit field work will be May 14, 15 and 16th. A motion was offered by Trustee Houserman, seconded by Trustee Eavey, to approve and accept the Treasurer's expenditure/revenue report and balance sheet dated March 31, 2018. **Motion was carried by voice vote, as presented.**

Superintendent White covered the DPW report. Trustee Houserman asked if our water testing covered PFAS. No it does not but Department of Environmental Quality (DEQ) will be testing all community systems.
