DPW Report: Superintendent Randall reported they finished flushing, a tress at Lyons & Hawley, 2 on the Island and one in Robinson Park will be coming down. They have two water leaks; one was our cost the other was a customer's. Should be fixed this coming Thursday. They had issues with the grinder pump, he thinks all is well now. Fred has been cleaning up the Island with DPW busy picking up after him. He also talked about more police patrol but right now not possible due to staffing shortage. He stated that the lead-in on water meters need to be done but the new water meters aren't in yet. There are 14 houses on Tabor St that need to be done first due to the street already being torn up for the Tabor St project. Lyndon will check into the cost and we will go from there.
