Streets, Water/Sewer & Fire Committee: Chairperson Darling

Paving will begin. Streets being done: Baldwin St. from Felch to Bridge, W Isham from Libhart to Baldwin, E Isham from Higbee to Tabor St., Tabor St. will be paved south of Bridge St. Starting about 200 ft. south of Bridge St. {where we did a mill and fill a few years ago} To the end of the pavement going south toward the river.

Finance Committee: Chairperson Houserman

Chairperson Houserman presented the Proposal for our upcoming Audit. The cost last year was \$6,500 and this year it will be \$6,600. This is with the same Firm Gabridge & Co. Trustee Houserman made a motion to accept this proposal, seconded by Trustee Farrington, **Motion carried by voice vote, as presented.**

Chairperson Houserman presented two proposals for training purposes:

First proposal from BS&A for General Ledger training for the current treasurer and clerk. The cost, if it were to last a full day, would be \$850 but most likely would only take a half a day so the cost would then be \$425. This is a class that Eric Smith, the auditor that was hired to help clean up things, had suggested they take. Chairperson Houserman made a motion to accept this proposal, seconded by Trustee Farrington, **Motion carried by voice vote, as presented.**

Second Proposal was for the MGFOA Session Two Accounting Basics for both the current treasurer and clerk. Cost for this one-day training is \$100/per participant. Chairperson Houserman made a motion to accept this proposal, seconded by Trustee Farrington, **Motion carried by voice vote, as presented**

Ordinance Committee: Chairperson Russell

Chairperson Russell stated that letters in regards to lawn mowing would be going out soon to property owners who are in noncompliance with the mowing ordinance.
